IN THIS SAFE AND CARING ENVIRONMENT, YOUNG CHILDREN ARE ENCOURAGED TO EXPLORE AND CHALLENGE THEMSELVES AS THEY DEVELOP INTO INDEPENDENT HUMAN BEINGS. THE PROGRAM SUPPORTS CHILDREN IN MOVING TOWARDS MASTERY OF SELF AND THE ENVIRONMENT. OUR MIDDLE SCHOOL PROGRAM RECOGNIZES THE TREMENDOUS POWER AND POTENTIAL OF THIS AGE AND PROVIDES A NURTURING ACADEMIC COMMUNITY, WHICH POSITIVELY SUPPORTS AND CHALLENGES ADOLESCENTS.
