

Elementary Basketball

Our Elementary Basketball League is open to our 3rd, 4th and 5th year students. This league is run by the East Maui County Parks and Recreation.

Practices will be held on Mondays and Thursdays on our Upper Field Basketball Courts from 3:10pm to 4:10pm. Practice will begin on Thursday, November 9th. Practices are not scheduled over Winter Break (12/18/17-1/5/18). They will resume on Monday, January 8, 2018.

The limit of players per team is 12 students. We will have 2 teams. Sign-ups are first come first serve. If our teams are filled we will make every effort to find extra coaches to add more teams. We will not accept late sign-ups.

The deadline to sign your child up is November 8, 2017

Your child should have a water bottle, snack, athletic shoes and a basketball for practice.

Games will be scheduled and begin in January. Once the game schedule is set it will be distributed to parents.

Parents will be notified by 1pm by email if practice will be canceled due to inclement weather. Please be sure to check your emails on practice days.

Montessori School of Maui Sports

The Mustangs are the Montessori School of Maui's interscholastic sports teams. Ages of participation vary according to county guidelines for the various sports, and are clearly defined for each specific sport team. Participation does not generally begin before Lower Elementary. We aim to have games scheduled against other schools that share our philosophical approach to sports and against whom we are fairly matched. Teams have competed (depending on participation numbers) in cross-country, volleyball, basketball and flag football.

OUR PRIORITIES WITH SPORTS:

- Improve fitness;
- Learn skills and fundamentals;
- Develop sportsmanship, to respect your own teammates, the other team and the referees;
- Have fun playing with friends and classmates:
- Learn to work together as a team;
- Challenge yourself against worthy competition;
- Play hard;
- Build team and school spirit;
- Show commitment and courtesy to the team timely arrival and preparedness for practice and games;
- Win gracefully and lose gracefully. Winning is usually more fun, and we like to win; but the young athlete learns about life by experiencing both outcomes.

We encourage all eligible athletes (age ranges outlined by each sport) to come out for the team. We rely on volunteer coaches, and are often limited to team size by outside regulations. Should there be more participants interested than the regulations or coaching team can accommodate, we make every attempt to have multiple teams.

It is our design to give every player playing time, and playing time will be based on practice attendance and effort at practice. We practice and play after school hours, and assume that team members want to be at every game and every practice. We encourage full and consistent participation because that is better for both the individual player and the team.

GUIDELINES FOR PARENTS AT GAMES:

- Ensure your child arrives prepared and in a timely manner to both practices and games;
- Be encouraging your presence alone communicates that clearly:
- Let the coach give instructions to the players during the game. When others shout instructions to players during the game, it is confusing;
- Model good sportsmanship for your child and the community;
- Appreciate the coaches, the other team and the officials without them, there is no game:
- Read the list of priorities above. These are the values we uphold with our student athletes and we ask you to support them.
